Summary of Requirement

EFRA wishes to contract a **sole official supplier** for the production of the EFRA device called "NitroMax 16EU" & the NitroMax 25.

EFRA is seeking to enter into an agreement for two years, starting on 1st March 2022 with an option for EFRA to extend the contract for a further period, under the terms and conditions set out in the following lines:

The selection criteria will be the following:

0 Condition "sine qua non": The official supplier **MUST BE** an EFRA ASSOCIATED MEMBER for the period of the tender and it's possible extension.

- 1 Accuracy and Quality: EFRA has set at the past EFRA AGM 2021 that the new EFRA "NitroMax 16EU" will be calibrated to a density of 0.859. The quality of the product must be stable enough and with the maximum accuracy possible. The EFRA NitroMax 25 will be calibrated to a density of 0.91.
- 2 Price: The Retail price of the product/s should be also taken into consideration as the RC Nitro industry and practitioners will take the device/s as the new reference and the cost of it must be a reasonable one/s.
- 3 The official supplier must provide EFRA 10 units of each annual or bi annual production batch for the NitroMax 16EU and 4 units respectively for the NitroMax 25, the batch reference must be engraved as well in the product, together with the appropriate EFRA logo.
- 4 All costs related to this agreement are assumed to be handled by the appointed official supplier and will not be covered by EFRA.

Interested parties are requested to send a Tender with a sample of each of the 2 products if possible before the 20:00 CET on 25th December 2021 the latest to the earlier mentioned EFRA Contacts.
